MISSION

THIS TOKEN WAS DESIGNED TO PROVIDE USERS WITH A UNIQUE TRADING EXPERIENCE FOCUSED ON COMMUNITY INVOLVEMENT AND STABLE VALUE GROWTH. THROUGH COMMUNITY EVENTS, INCENTIVES FOR HOLDERS, AND MONTHLY LOTTERIES, FOMO1 SEEKS TO ENSURE THE TOKEN'S VALUE CONTINUES TO RISE, CREATING INCENTIVES FOR BOTH NEW AND LONG-TERM HOLDERS ALIKE.



UNIQUE VALUE PROPOSITION

FOMO1 IS A DIGITAL CURRENCY THAT CENTERS AROUND CREATING A SENSE OF URGENCY AND BELONGING. THE TOKEN INTEGRATES MANUALLY MANAGED MECHANISMS THAT PROMOTE EARLY PURCHASES AND LONG-TERM HOLDING.

KEY ELEMENTS OF FOMO1

INCENTIVES FOR HOLDERS – TOKEN HOLDERS RECEIVE REWARDS BASED ON THE QUANTITY AND DURATION OF THEIR HOLDINGS, ENCOURAGING USERS TO RETAIN THE TOKEN OVER TIME AND REINFORCING LOYALTY.

TIME-LIMITED EVENTS – ONCE A MONTH, FOMO1 HOSTS A SPECIAL EVENT WITH PREFERRED CONDITIONS, SUCH AS REDUCED FEES OR INCREASED REWARDS, DRIVING URGENCY AND PROMPTING USERS TO ACT PROMPTLY.

MONTHLY LOTTERIES WITH SPECIAL REWARDS – MONTHLY LOTTERIES AMONG TOKEN HOLDERS OFFER UNIQUE PRIZES, SUCH AS ADDITIONAL TOKENS, DAO VOTING RIGHTS, OR EXCLUSIVE EVENT ACCESS. THIS MECHANISM STRENGTHENS THE SENSE OF COMMUNITY AND FOMO WITHIN THE PROJECT.

WEEKLY COMPETITIONS AND LOTTERIES – SMALL WEEKLY LOTTERIES BASED ON TOKEN HOLDINGS, WHERE ANYONE HOLDING A MINIMUM AMOUNT OF **FOMO1** TOKENS IS ELIGIBLE, WITH PRIZES LIKE ADDITIONAL TOKENS OR VOTING RIGHTS IN THE **DAO**. THIS MODEL NOT ONLY ENCOURAGES PURCHASES AND HOLDING BUT ALSO BOOSTS USER ENGAGEMENT.

TEMPORARY DISCOUNTS ON LARGE PURCHASES – EACH MONTH, A "48-HOUR WINDOW OF OPPORTUNITY" OFFERS FEE DISCOUNTS FOR USERS WHO BUY A SUBSTANTIAL AMOUNT OF **FOMO1**. THIS DISCOUNT IS MANUALLY MANAGED, ALLOWING INVESTORS TO INCREASE THEIR HOLDINGS AND BENEFIT FROM ADDITIONAL REWARDS.

REFERRAL BONUSES FOR FRIENDS – A REFERRAL SYSTEM WHERE USERS WHO SUCCESSFULLY INVITE A FRIEND TO PURCHASE **FOMO1** RECEIVE A MANUAL BONUS. THIS STRATEGY SUPPORTS COMMUNITY EXPANSION AND INCREASES THE USER BASE.

SPECIAL COMMUNITY EVENTS – EVERY FEW MONTHS, A UNIQUE COMMUNITY ACTIVITY, LIKE A VOTE ON A SPECIFIC IMPROVEMENT, REWARDS PARTICIPANTS. THESE EVENTS STRENGTHEN THE SENSE OF BELONGING AND **FOMO** SURROUNDING PARTICIPATION.

VETERAN HOLDERS' REWARDS – SPECIAL BONUSES FOR LONG-TERM HOLDERS WHO RETAIN THE TOKEN FOR EXTENDED PERIODS (E.G., SIX MONTHS OR MORE). THESE REWARDS COULD INCLUDE ADDITIONAL TOKENS OR ENHANCED VOTING RIGHTS, ENCOURAGING LONG-TERM COMMITMENT.

PERIODIC PURCHASE CHALLENGES – MONTHLY CHALLENGES INVITING THE COMMUNITY TO BUY A SET AMOUNT OF TOKENS DURING A SPECIFIC MONTH. PARTICIPANTS WHO MEET THE CHALLENGE RECEIVE A BONUS CALCULATED AS 1% OF THE PURCHASED AMOUNT, HEIGHTENING INTEREST IN PURCHASES DURING THE CHALLENGE WINDOW.

FOMO1 STAKING MODEL

MANUAL TRADE-BASED REWARDS

IN THE FOMO1 STAKING MODEL, REWARDS FOR STAKING PARTICIPANTS COME FROM A SMALL PERCENTAGE OF THE PROJECT'S ACTUAL TRADING ACTIVITY. THIS APPROACH BASES REWARDS ON THE PROJECT'S REVENUE AND PROFITS, ELIMINATING THE NEED TO ISSUE NEW TOKENS. THIS MODEL ENCOURAGES THE COMMUNITY TO ALIGN WITH THE PROJECT TEAM, STRENGTHENING THE SENSE OF PARTNERSHIP AND SHARED INVESTMENT IN THE PROJECT'S SUCCESS.



STRUCTURE OF THE STAKING MODEL



MONTHLY STAKING REWARDS ALLOCATION FROM REVENUE

EACH MONTH, A SMALL PERCENTAGE OF TOTAL EARNINGS FROM FOMO1 SALES AND TOKEN PURCHASES WILL BE ALLOCATED TO A STAKING REWARDS POOL. THIS PERCENTAGE, DETERMINED BY THE PROJECT TEAM (E.G., 1%-2% OF MONTHLY PROFITS), IS DEDICATED TO REWARDING STAKING PARTICIPANTS ACCORDING TO THEIR COMMITMENT LEVEL.

REWARDS BASED ON HOLDING DURATION

STAKING PARTICIPANTS ARE GROUPED BY HOW LONG THEY HAVE HELD TOKENS. THE LONGER THE HOLDING PERIOD, THE LARGER SHARE THEY RECEIVE FROM THE REWARDS POOL, AS FOLLOWS

- LESS THAN 1 MONTH: 10% OF THE POOL
- 1-3 MONTHS: 20% OF THE POOL
- 3-6 MONTHS: 30% OF THE POOL
- MORE THAN 6 MONTHS: 40% OF THE POOL

ADDITIONAL REWARDS FOR ACTIVE COMMUNITY ENGAGEMENT

IN ADDITION TO STAKING REWARDS, USERS WHO ACTIVELY ENGAGE IN COMMUNITY ACTIVITIES—SUCH AS PARTICIPATING IN DAO VOTES, HELPING WITH PROMOTIONAL ACTIVITIES, OR PROMOTING THE PROJECT—ARE ELIGIBLE FOR A BONUS FROM THE MONTHLY REWARDS POOL. THIS BONUS IS DESIGNED TO ENHANCE HOLDER COMMITMENT AND FOSTER A STRONG COMMUNITY FOUNDATION.

MONTHLY TRANSPARENCY AND TRADE REWARD REPORTS

EACH MONTH, THE FOMO1 TEAM WILL PUBLISH A TRANSPARENCY REPORT DETAILING PROJECT REVENUE, THE PERCENTAGE ALLOCATED TO THE REWARDS POOL, AND THE DISTRIBUTION OF REWARDS AMONG HOLDERS BASED ON HOLDING DURATION AND COMMUNITY ACTIVITY. THESE REPORTS ALLOW THE COMMUNITY TO TRACK THE PROJECT'S FINANCIAL HEALTH AND UNDERSTAND THE CONNECTION BETWEEN ITS SUCCESS AND ITS REWARDS.
